Proceedings:

The meeting for feedback analysis was convened by Dr. Tukaram Manikrao Varat, the College Principal and Chairman of the Internal Quality Assurance Cell (IQAC). The meeting was conducted under the joint leadership of Principal and IQAC Co-ordinator Kishor Bhausaheb Take. The primary objective of the meeting was to analyse the feedback collected from students, teachers, employers, alumni, and parents.

Agenda 1: Overview of Feedback Collection and Analysis

During this agenda item, the participants discussed the total number of feedback forms collected. It was reported that a comprehensive total of feedback forms had been gathered from the various stakeholder groups. The attendees acknowledged the importance of the feedback collection process and its contribution to enhancing the institution's quality.

2: Responses to Feedback

- 1. Student Feedback:** It was noted that the feedback regarding 'online education resources in the library' was unsatisfactory. The absence of available online resources was identified as a concern, and steps will be taken to address this issue.
- 2. Teacher Feedback:** Teachers expressed dissatisfaction with the availability of the college canteen for their use. The administration will review the current canteen facilities and consider improvements to better serve the faculty members.
- 3. Employer Feedback:** Employers' feedback was positive across all mentioned points in the feedback form, reflecting their satisfaction with the skills and knowledge of the graduates.
- 4. Alumni Feedback:** Alumni feedback was positive for all the points mentioned in the feedback form, indicating the institution's positive impact on their academic and professional growth.
- 5. Parents Feedback:** Parents indicated dissatisfaction with 'Student counselling and guidance.' The IQAC and relevant departments will work together to strengthen and expand student counseling and guidance services.

3: Action Plan for Suggestions

The meeting participants collaboratively devised an action plan to address the feedback and suggestions:

1. To address the concern about 'online education resources in the library,' the library management will assess the digital resources available and work on expanding the online collection.
2. The administration will review the status of the college canteen and consider possible enhancements based on teachers' feedback.
3. The institution will continue to maintain the high standards that have garnered positive feedback from employers and alumni.

4. In response to parents' concerns about student counseling and guidance, the institution will allocate resources to strengthen and improve counseling services.



5. Conclusion:

The meeting concluded with a commitment from Dr. Tukaram Manikrao Varat, IQAC Co-ordinator Kishor Bhausaheb Take, and other attendees to implement the action plan and address the feedback points raised during the analysis. The participants expressed their dedication to further enhancing the institution's quality and services based on the valuable input from various stakeholders.
