Proceedings:

The meeting for feedback analysis was convened by Dr. Sudhakar Murlidhar Kurhade, the Principal and Chairman of the Internal Quality Assurance Cell (IQAC). The meeting was conducted under the joint leadership of Principal and IQAC Co-Ordinator Sayyed Hamid Sharfuddin. The primary objective of the meeting was to analyse the feedback collected from students, teachers, employers, alumni, and parents.



1. Overview of Feedback Collection and Analysis:

Sayyed Hamid Sharfuddin - Co-Ordinator, IQAC began the meeting by providing an overview of the Feedback Collection and Analysis process. He informed the attendees that feedback forms were distributed to various stakeholders, including students, teachers, employers, alumni, and parents, to gather their valuable insights and perspectives on the institution's performance. The total number of feedback forms collected was discussed, highlighting the successful engagement of the different stakeholder groups in sharing their opinions.

2. Responses of Feedback:

The meeting proceeded with an in-depth analysis of the feedback received from each stakeholder group:

Student Feedback: It was noted that while the majority of student feedback was positive, there were concerns regarding the 'Online education resources and internet facility provided in the library.' Students expressed dissatisfaction with the quality of online resources and the reliability of internet access. This raised the need for targeted improvements in these areas to enhance the overall learning experience.

Teacher Feedback: The analysis indicated that teachers were generally satisfied with all the points mentioned in the teacher feedback form. This positive feedback highlighted the institution's success in meeting the expectations and requirements of the teaching staff.

Employer Feedback: The feedback from employers revealed dissatisfaction with 'Punctuality and promptness in job.' This observation prompted a discussion on implementing measures to address these concerns and better prepare students for the professional world.

Alumni Feedback: The analysis of alumni feedback indicated a high level of satisfaction across all points mentioned in the feedback form. This positive feedback underscored the institution's ability to maintain its standards and quality of education even after the students' graduation.

Parents Feedback: Overall, parents' feedback was satisfactory, with a note that some points were mentioned as 'not sure.' These specific points were identified for further clarification through focused interactions with parents to better understand their perspectives.



3. Action Plan for Suggestions

The meeting concluded with a collaborative discussion on actionable steps based on the feedback analysis:

A dedicated committee will be established to address the concerns raised by students about online education resources and internet facilities in the library. The committee will explore ways to enhance the quality of online resources and ensure dependable internet access for seamless learning.

Efforts will be initiated to enhance students' awareness and understanding of the importance of punctuality and promptness in their professional endeavors. Workshops, training sessions, and mentorship programs will be considered to address this feedback from employers.

The 'not sure' points highlighted by parents will be further investigated through direct interactions with parents, surveys, and open forums. This proactive approach will help gather additional insights and provide clarifications on the areas of concern.

Meeting Adjournment:

The meeting was adjourned at by Dr. Sudhakar Murlidhar Kurhade, expressing gratitude to all participants for their valuable contributions and commitment to continuous improvement.
